*The Senate combined three FY2012 appropriations bills into one, colloquially called a "minibus" because it had fewer of the 12 appropriations bills in it than an "omnibus" bill. The three bills – Agriculture, Commerce-Justice-Science (CJS), and Transportation-HUD (T-HUD) – were considered under this House bill number for the Agriculture bill. The House never passed the individual CJS or T-HUD bills, but the two chambers agreed to conference on a final measure anyway. The CJS bill had been reported from the House committee, but the T-HUD bill was not. H.R.

2112 also contained a Continuing Resolution (CR) to keep the other government agencies operating until December 16, 2011.

** The other nine FY2012 appropriations bills were combined into H.R. 2055, the FY2012 Military Construction, Veterans Affairs bill. Many of the individual bills were not passed by the House or Senate or reported from committee or even marked up at subcommittee level.

† The Senate Armed Services Committee reported S. 1253 on June 11, 2011 (S. Rept. 112-26). However, on November 15, 2011, it approved a different bill, S. 1867, and sent it to the Senate floor <u>without a written report</u>. In conference with the House, the House bill number – H.R. 1540 – was used.

<u>Committees of Jurisdiction</u> for bills listed or expected to be listed in this fact sheet (see their websites or <u>Thomas</u> for more detailed information on legislative action)

- DOD Authorization: <u>House Armed Services Committee</u>, <u>Senate Armed Services Committee</u>. The Strategic Forces Subcommittee has jurisdiction over most space programs.
- Defense Appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations Committee</u>. The Defense Subcommittee has jurisdiction over most space programs.
- DOE Appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations Committee</u>. The Energy and Water Development Subcommittee has jurisdiction over the Department of Energy (DOE). DOE produces radioisotope power systems used by NASA for certain space science missions and provides the plutonium-238 fuel for them. It also cooperates with NASA on certain high energy physics missions such as Fermi (formerly GLAST).
- FAA Office of Commercial Space Transportation authorization: <u>House Science, Space and Technology Committee</u>; <u>Senate Commerce, Science and Transportation Committee</u>.
- FAA Office of Commercial Space Transportation appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations</u>
 <u>Committee</u>. The Transportation-Housing and Urban Development (T-HUD) Subcommittee has jurisdiction over FAA.
- Intelligence Authorization: <u>House Permanent Select Committee on Intelligence</u>, <u>Senate Permanent Select Committee on Intelligence</u>. (Appropriations for the Intelligence Community are included in the defense appropriations bill.)
- NASA Authorization: House Science, Space and Technology Committee; Senate Commerce, Science and Transportation
 Committee. The House SS&T Subcommittee on Space and Aeronautics and the Senate Commerce Subcommittee on Science and Space have jurisdiction over NASA programs. The House SS&T Subcommittee on Energy and Environment and the Senate Commerce Subcommittee on Oceans, Atmosphere, Fisheries and Coast Guard have jurisdiction over NOAA.
- NASA Appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations Committee</u>. The Commerce, Justice, Science (CJS) Subcommittee has jurisdiction over NASA programs.
- NOAA Appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations Committee</u>. The Commerce, Justice, Science (CJS) Subcommittee has jurisdiction over programs of the National Oceanic and Atmospheric Administration (NOAA, part of the Department of Commerce). NOAA is responsible for civil weather satellites and other operational earth observation satellites.
- USGS Appropriations: <u>House Appropriations Committee</u>, <u>Senate Appropriations Committee</u>. The Interior and Environment Subcommittee has jurisdiction over the U.S. Geological Survey (USGS), part of the Department of the Interior. USGS for many years has managed archiving and distribution of imagery from the Landsat series of satellites.
