Note 1: H.R. 244, the HIRE Vets Act, was used as the legislative vehicle for the FY2017 Consolidated Appropriations Act (or “omnibus”). It is common for Congress to use existing, but unrelated, legislation in this manner because the bill has already passed through part of the legislative process, speeding up consideration of the appropriations measure. Previous action on H.R. 244 is irrelevant for this purpose.

Note 2: Johnson introduced a revised version of the bill as an amendment to H.R. 2810, the FY2018 National Defense Authorization Act. It [passed](#) as part of an en bloc amendment on July 14, 2017. [A modified version was included in the final version of the bill.](#)

Note 3: For floor action, the House bundled four of the 12 regular FY2018 appropriations bills, including Defense, into the “Make America Secure Act” and uses the bill number assigned to the Defense Appropriations bill, **H.R. 3219**. The other three bills in this “national security” bundle are: Military Construction/Veterans Administration (H.R. 2998), Energy and Water (H.R. 3266), and Legislative Branch (H.R. 3162). However, the Senate did not take up the bill. In January 2018, the House passed a stand-alone defense appropriations bill. As reported from the House Appropriations Committee, it was **H.R. 4877**. It was incorporated into H.R. 695, an unrelated bill that was used as the legislative vehicle for passing the bill (because it was already part way through the legislative process). The House Appropriations Committee said it was “virtually the same” as H.R. 3219.

Note 4: The FY2018 Intelligence Authorization Act was first brought to the House floor on July 24, 2017 for a vote under the “suspension” calendar. That refers to suspension of the rules, meaning a bill may be brought to the floor without going through the House Rules Committee. It is an expedited procedure used for bills that are thought to be non-controversial and can easily win two-thirds of the vote, which is required for passage under this process. However, the bill did not win two-thirds of the vote. Many Democrats voted against it because they felt that in a year when the Intelligence Committee is investigating Russia’s involvement in the U.S. election, regular order should prevail where there is debate and amendments may be offered. The bill subsequently went to the Rules Committee and returned to the House floor for debate under regular order on July 28. It passed.

Note 5: H.R. 601 is the legislative vehicle used for a FY2018 Continuing Resolution (CR) to fund the government for the first part of FY2018 (through December 8, 2017). It also extended the debt limit and the flood insurance program through that date, and provided \$15.25 billion for hurricane relief (Hurricane Harvey). Action on H.R. 601 prior to September 5, 2017 is not relevant to its final purpose.

Note 6: For floor action, the House [bundled the remaining eight FY2018 appropriations bills](#) together as H.R. 3354, which is the number for the Interior and Environment bill. (The other four regular appropriations bills are bundled as H.R. 3219). The eight bills bundled in H.R. 3354 include the Commerce-Justice-Science bill (H.R.3267) that funds NASA and NOAA, and the Transportation-HUD bill (H.R. 3353) that funds the FAA’s space office.

Note 7. The supplemental appropriations bill providing disaster assistance for hurricanes Harvey, Irma and Maria, and wildfires, includes \$81.3 million to repair NASA facilities, \$16.3 million to repair NSF’s Arecibo radio telescope in Puerto Rico (which NASA uses), and \$50 million for NOAA to improve supercomputing infrastructure and satellite ground services used in hurricane intensity and track prediction (how the \$50 million is allocated between those two activities is not specified).

Note 8: Congress is using H.R. 1370 as the Further Continuing Appropriations bill to keep the government funded through January 19, 2018 after the expiration of an earlier Continuing Resolution (H.J. Res.123) on December 22, 2017. H.R. 1370 originally was an anti-human trafficking bill affecting activities at the Department of Homeland Security, but was repurposed as the Further Continuing Appropriations Act, 2018. [The House Appropriations Committee originally introduced H.J. Res. 124 as the Further Continuing Appropriations act, which would have provided full year funding for DOD, but funding for the other agencies only until January 19, but no action was taken on it because of strong opposition, especially by Democrats. H.R. 1370 is the replacement and funds DOD like the other agencies until January 19, with exceptions for two programs that will receive additional funding.

Note 9: Congress used H.R. 195, the Federal Register Printing Savings Act, as the legislative vehicle for the fourth FY2018 Continuing Resolution to keep the government funded at FY2017 levels. Prior action on H.R. 195 is not related to the bill’s new purpose. This is the fourth CR for FY2018. The version passed by the House on January 18 would have extended funding until February 16. The Senate passed a modified version on January 22, following a 3-day government shutdown, that extended funding only to February 8. The House agreed with the Senate modification on January 22.

Note 10: The Bipartisan Budget Act of 2018 is a multi-part bill that extends the Continuing Resolution in effect for most government agencies until March 23, 2018; raises the budget caps imposed by 2011 Budget Control Act for FY2018 and FY2019; provides \$80 billion in disaster aid; and extends suspension of the debt limit through March 1, 2019. The underlying bill, H.R. 1892, was on an unrelated topic, but was used as the legislative vehicle for this budget agreement. Action on the bill prior to February 2018 is not relevant.

Note 11: The FY2018 Consolidated Appropriations Act, also called the “omnibus,” was released by the House Appropriations Committee in the evening of March 21, 2018. The House Rules Committee met at 10:00 pm ET to approve a rule for the bill’s consideration. The bill was passed by the House at about 12:30 pm on March 22, and by the Senate at about 12:30 am March 23. President Trump signed it into law about 1:00 pm March 23. Hence, it took less than 48 hours for the 2,200-page bill appropriating \$1.3 trillion for FY2018 to be introduced, passed by both chambers, and signed into law. The underlying bill, H.R. 1625, originally on an unrelated topic, was used as the legislative vehicle for the appropriations measure, which provides funding for most government agencies for FY2018 (through September 30, 2018). NASA and NOAA are in Division B, Commerce-Justice-Science. The bill and accompanying report language are posted on the House Rules Committee website.

Note 12: H.R. 302 is being used as the legislative vehicle for the FAA Reauthorization Act, which including funding authority and direction for the FAA's Office of Commercial Space Transportation. As introduced, it dealt with sports medicine licensure, but was repurposed to also include the FAA reauthorization, funding for hurricane relief (Hurricane Florence) and other purposes.

Note 13: H.R. 695 was the FY2018 Defense Appropriations bill, but was repurposed as the legislative vehicle for an extension to the FY2019 Continuing Resolution (CR) to keep parts of the government operating through Feb. 8, 2019.
