Congresses begin on January 3 every other year so the 111th Congress, for example, was January 3, 2009-January 3, 2011. The others were 2011-2013, 2013-2015, 2015-2017, 2017-2019, 2019-2021, 2021-2023, and 2023-2025. respectively.

“**Ord. Rpt.**” means the bill was “ordered reported” from the committee -- the committee approved it and ordered that it be reported to the House or Senate, but the report has not been filed yet, so there is no report number. “**Skld**” – scheduled. **N/A** – no action or not applicable.

NDAA is the National Defense Authorization Act. **E&C** is the House Energy and Commerce Committee. **CJS** is the Commerce-Justice-Science appropriations bill that includes NASA and NOAA. **THUD** is the Transportation-HUD appropriations bill that includes the FAA and its Office of Commercial Space Transportation.
